Our girls range from grades 10–12 and will represent several of the eight counties that Girl Scouts of West Central Florida serve.



- Engage the girls as much as possible (including mealtimes) some will have no problem carrying out a conversation and others will need more encouragement.
- "Be present" and keep calls, texts and emails to a minimum. This is not only for the girls' benefit, but also as a courtesy to our speakers and presenters.
- Girls have been grouped with coaches based on similar interests and their career goals.
- The girl-coach relationship is intended for the duration of the weekend, but you are welcome to extend your mentorship beyond Camp CEO if that is what you and she decide.
- Like all Girl Scout programs, Camp CEO is girl-led. Coaches are there to encourage and guide the girls during discussions and activities, but should not be leading it.


